

Terms and Conditions of Use

Welcome to the tonydeoleo.com website (the "Tonydeoleo.com Official Site"), a website owned and operated by Deoleo Digital Publishing LLC. The terms and conditions stated below, along with the policies and guidelines located throughout the Tony Deoleo.com Site (collectively herein the "Terms of Use") identify what a user of the tony deoleo.com Site ("you" or "your" or "User" or "Users") can expect from Deoleo Digital Publishing LLC, owner of tonydeoleo.com website, and affiliates (together referred to herein as "Deoleo Digital Publishing LLC", "we", "us" or "our"), and/or persons who provide products or services to Deoleo Digital Publishing LLC customers either directly or through the tonydeoleo.com Site ("Tonydeoleo.com Providers") and what Deoleo Digital Publishing LLC in turn expects from Users. These Terms of Use constitute a legally binding agreement between you and Deoleo Digital Publishing LLC. Please read these Terms of Use carefully before using the tonydeoleo.com Site or Tonydeoleo.com Services (as defined below).

By visiting any area on the Tonydeoleo.com Site, creating an account, making a purchase via the Tonydeoleo.com Site, downloading a Deoleo Digital Publishing LLC retail E-book ("Deoleo Digital Publishing E-book") from the Tonydeoleo.com Site, joining any Deoleo Digital Publishing LLC online interactive community, posting a review or creating a profile, or otherwise joining, viewing, visiting or contributing to Deoleo Digital Publishing user forums, blogs, or interactive features (all of the foregoing are sometimes referred to in this document as the "Tonydeoleo.com Services"), you agree that you have read, understood, and agree to be bound by the Terms of Use. 1. LICENSES AND RESTRICTIONS

1.1 Licenses. 14. APPLICABLE LAW; JURISDICTION

15.1 Applicable Law. The TonyDeoleo.com Site is created and controlled by Deoleo Digital Publishing in the State of California. The laws of the State of California will govern the Terms of Use, without giving effect to any principles of conflicts of laws.

15.2 Jurisdiction. Each of Deoleo Digital Publishing and User agrees to submit to the nonexclusive personal jurisdiction of the courts located within Los Angeles County, California, and waives any objection to the laying of venue of any litigation in said courts.

15. DISPUTE RESOLUTION

15.1 Arbitration. Any claim or controversy at law or equity that arises out of the Terms of Use, the Tonydeoleo.com Site or any Tonydeoleo.com Service (each a "Claim"), shall be resolved through binding arbitration conducted by telephone, online or based solely upon written submissions where no in-person appearance is required. In such cases, the arbitration shall be administered by the American Arbitration Association under its Commercial Arbitration Rules (including, without limitation, the Supplementary Procedures for Consumer-Related Disputes, if applicable), and judgment on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof.

15.2 Deoleo Digital Publishing's Option to Litigate. Alternatively, at Deoleo Digital Publishing 's sole option, a Claim (including Claims for injunctive or other equitable relief) may be adjudicated by a court of competent jurisdiction located in Los Angeles County, California.

15.3 No Consolidation. Any Claim shall be arbitrated or litigated, as the case may be, on an individual basis and shall not be consolidated with any Claim of any other party whether through class action proceedings, class arbitration proceedings or otherwise.

15.5 Jury Trial Waiver.
